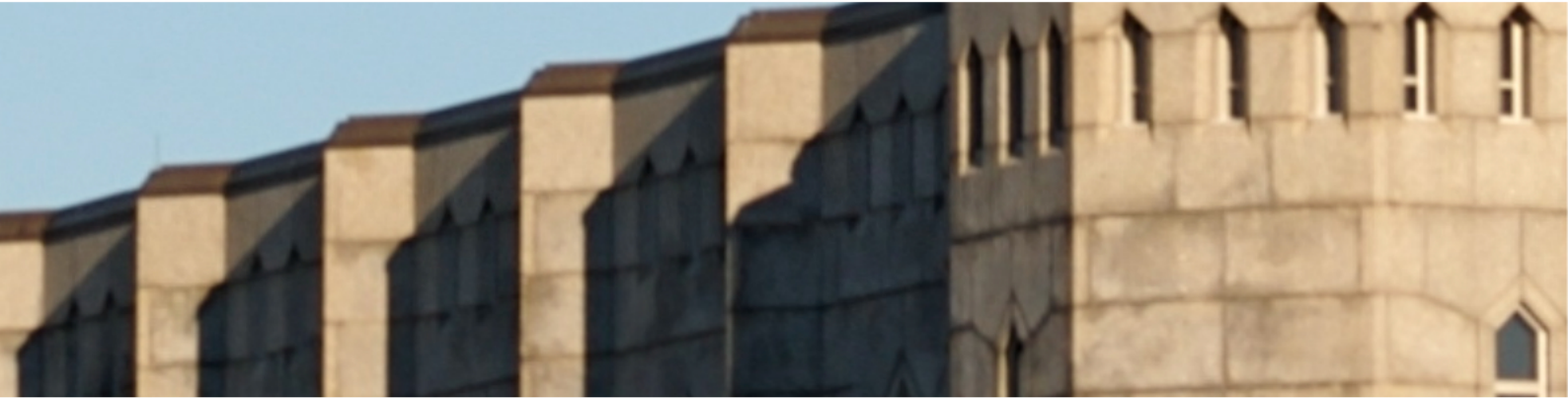

Description / informations générales

Université Laval was the very first French-language university in North America. In 1663 Monsignor François de Montmorency-Laval, the first bishop of New France, founded the colony's first educational institution: Séminaire de Québec. Nearly 200 years later, in 1852, this institution became a university and the first building block for all French-language higher education in Québec, Canada, and North America.

The history of Université Laval is closely tied to that of Québec. For centuries this institution of higher learning has trained the intellectual elite of French-speaking Québec, and its influence continues to this day. Université Laval is considered a bulwark in the continued presence and thriving of the French fact in North America.

Logement

On campus residence halls:

Université Laval has 4 residence buildings on its campus, of which 3 are co-ed and 1 for women only. Every year, more than 2,300 students choose to live there.

A certain number of rooms in the student residences are reserved each semester for exchange students. Laval send students a reservation form they have to fill out and send to the Service des résidences to reserve a room.

Frais à prévoir

Living and Prospective costs (CAN\$) : \$5,000\$-\$8,000/semester

Included :

Food: around \$350/month

Housing: around \$350/month (in residence)

Off-campus housing: around \$300 to \$600/month (depending on location and whether sharing cost with others)

Insurance: around \$300/semester (mandatory for international students). All international students are automatically covered by the Université Laval group health and hospitalization insurance plan. This coverage is mandatory and costs around \$300 per semester. It cannot be replaced by any personal insurance. Students from countries with which the Québec government has entered into a reciprocal social security agreement may be exempt.

Leisure and other expenses: around \$400/month
